Consultancy services should be provided by a team of international and national experts with proven work experience under similar conditions, as well as in the application of the World Bank Environmental and Social Standards.

The average annual turnover of the consultant or the consortium, calculated as the mean value for the last three years, shall be at least greater than **EUR 1,600,000** and the current ratio for the last three years (working capital/current liabilities) **greater than 1**.
